- 4. Any breakages or shortages should be reported within 3 days of delivery or no claims will be accepted by the company.**
- 5. Title to goods shall not pass to the purchaser until the invoice price and any other money is paid in full although risk in the goods passes to the purchaser on receipt.**
- 6. All goods installed are deemed as acceptance no claims will be accepted by the company unless manufacturing defect arises after installation.**
- 7. All goods supplied are not guaranteed by the company but are covered by manufacturers guarantee should any fault arise.**
- 8. While the company will endeavour to meet estimated dates for delivery of goods, it undertakes no obligation to deliver by such dates and the company shall not be liable for any damage or consequential loss resulting from any failure to deliver by such dates however caused.**
- 9. Unless otherwise agreed in writing payment in full is due not later than the end of the month following the date of invoice.**
